

Rules and Regulations for the use of the pool at Pebble Creek Swim Club

Pebble Creek Swim Club has the following rules and regulations to ensure a safe and efficiently run pool facility. We aim to provide a place of continuing enjoyment for pool members. Members, parents, caregivers are responsible for explaining these rules as well as the consequences for breaking them, to their children and guests. Pool management may suspend individuals for non-compliance. Member complaints or grievances may be referred to the pool Manager(s) or in writing to Pebble Creek Swim Club (info@pcswimclub.net)

Admittance

- Only Members and paying guest of Members will be admitted. Must present a valid Membership card.
- Pebble Creek Swim Club may, at their discretion, restrict further access to the facility if they determine that the facility has reached its Maximum Bather Load or unsafe conditions exist due to overcrowding, in addition they may prohibit guests when necessary, to relieve overcrowding.
- Pebble Creek Swim Club reserves the right to refuse admission to anyone with skin abrasions, colds, coughs, inflamed eyes, nasal or ear discharge, open blisters, athlete's feet, infectious disorders or communicable diseases.
- Children twelve (12) years and under must be accompanied by a person at least eighteen (18) years of age who must accept responsibility for the safety and conduct of the child.
- Pebble Creek Swim Club reserves the right to refuse admittance to, eject from the pool premises, or remove membership privileges, any persons failing to comply with any health and safety regulations.

Entire Facility

- All persons shall use the pools and facilities at their own risk. The lifeguard may refuse a swimmer admission to any area of any pool if the swimmer does not exhibit sufficient skill to insure his or her safety.
- Members must obey the Lifeguards on duty at all times. Failure to do so may result in ejection from the complex or the loss of membership privileges.
- Identification cards must be shown for admission to the pool.
- Identification cards are non-transferrable.
- If a ID card is lost, please notify Pebble Creek Swim Club (info@pcswimclub.net). A fee of \$5.00 will be charged to replace an ID card.

- Pebble Creek Swim Club wants all members and guests to enjoy their time. The following will help to ensure a successful and safe pool season:

- No Running on the deck area.
- No Diving in the shallow end.
- Only one diver on the board at one time.
- No standing, playing, or jumping off ladders or railings.
- Cut-offs or regular shorts are not permitted in the pool.
- No eating or drinking while in the pool or sitting on the sides of the pool.
- Glass bottles or containers of any kind should not be brought into the pool facility.
- No bikes, roller blades or skateboards.
- No use of the pool when the pool is closed or when reserved for private events.
- Be mindful of the safety and comfort of others and avoid roughness, rowdiness, profanity, or other such conduct.
- With the exception of guide animals for the handicapped, pets and animals are not allowed.

- No tobacco or alcohol shall be permitted on the grounds except for private events.
 - No one under the influence of alcohol or drugs will be permitted within the complex
 - For everyone's safety, competitive breath holding is not allowed.
 - No Hanging on lane dividers.
- Each bather should shower before entering the pool.
 - All refuse must be placed in the appropriate containers provided.
 - In case of an accident, report it to the lifeguard immediately. There is first aid equipment on the premises and trained personnel to use it.
 - Pebble Creek Swim Club shall not be responsible for any accident, injury, theft, or loss or damage to personal property in the pool complex.
 - The cost of any facility damage shall be charged to the responsible member including damage caused by the guest of the member.

Wading Pool

- Only children under five (5) years of age may use the wading pool.
- Children that are not toilet trained are required to wear swim diapers.
- Parents are responsible for children in this area.

Legal Statement

By accepting your membership, you as the applicant, as well as others you list on your application, or any guest you bring to the facility, agree to release and hold harmless the Pebble Creek Swim Club from any injuries resulting from the use of pool facilities. The applicant and all those listed on their application further agree to comply fully with the rules of Pebble Creek Swim Club, and to be responsible for and ensure the compliance of any guest they bring to the facility, with penalties for non-compliance ranging from member restrictions to full membership revocation. Member is also authorizing Pebble Creek Swim Club to release photos or other images that may include members or their guests. RULES AND REGULATIONS CAN BE MODIFIED FROM TIME TO TIME AS DEEMED APPROPRIATE AND NECESSARY BY THE POOL ADMINISTRATION.
